

Student Rules and Consent Agreement Between Fourth Baptist Christian School, Host Parents and International Student and Parents

- A. Health Care Treatment: The Parents or Guardians and/or the International Student consent and authorize the Host Family or School Authorities to obtain any medical, dental, surgical, psychological, psychiatric or hospital care, deemed necessary by any health care provider, for the health, treatment, and care of the Student during the Student's participation during the school year and duration of the stay in the United States. Further, the Parents or Guardians and/or the Student authorize the health care provider to release all health care records relating to the Student to the necessary entities in the case of medical treatment or to the Student upon their return to their country.
- B. The Parents or Guardians and/or Student agree to hold harmless School authorities or any adult Host Family member in decisions relating to the care of the Student in the case of any emergency medical issue. Host Family and Parents/Guardians of the Student will be in contact in the case of on-going medical/dental need that could come up in the course of the duration of the Student's stay.
- C. Rules for Students: The following Rules have been established by Fourth Baptist Christian School International students. These rules are expected minimum standards of participant conduct. Any infraction may result in immediate repatriation (return) of the Student to his/her home country:
 - 1. It has been arranged for you to attend school and attendance is mandatory. You must take classes in your host country's history, government, and language in addition to other required or challenging classes. You may not receive any failing marks/grades. In addition, you may not receive any repeated disciplinary detentions or suspensions from your school. Your classroom behavior and academic performance must be exemplary. Your host school makes the final decision about your grade level placement or academic credits and you must abide by that decision. Students attending the school for one year are not eligible to receive a high school diploma from Fourth Baptist Christian School. Participation in extracurricular school activities (sports, drama, band, etc.) is not guaranteed.
 - 2. All use, purchase or possession of alcohol, drugs, tobacco or harmful controlled substances is prohibited.
 - 3. Tattooing and body piercing are strictly prohibited during your stay.

4. You are not allowed to drive or purchase a motorized vehicle.
5. It is required that you spend the Christmas/New Year holidays and other major holidays and family celebrations with your Host Family. You are not allowed to travel outside your local area, either by yourself or with other teenagers without permission of your Host Family and natural parents/guardians. Travelling may be done with your Host Family, church, or school tour or trip.
6. You are not permitted to hitchhike.
7. You are not allowed to take a job during your stay.
8. All your activities must be approved by your Host Parents. You must always advise your host parents of your whereabouts and when you will return home.
9. You must abide by the decisions of your Host Family and Fourth Baptist Christian School authorities.
10. Visits by natural parents are discouraged during the school year, but certainly welcomed during breaks and after the last day of school when permission has been granted in advance. No visits by friends or siblings are allowed at any time during the Student's stay.
11. With the exception of voluntary returns or repatriations, you will not be permitted to return home until the conclusion of the school year at which time you would return to your home at that time.

Each Student and his/her Parent/Guardian must acknowledge that they understand and have agreed to adhere to the above Rules prior to the Student's final program acceptance.

Please indicate that you have read and fully understand all the above Consent agreement and Rules and that all the information provided on the application and accompanying paperwork provided by you is true and complete to the best of your knowledge by signing below. Any information found to have been withheld or misstated will subject the Student to termination from the acceptance into the school program.
